# A Word from the Elders

The Lord continues to use our pastoral internship program and our missionary-in-training ministries as a pipeline to further encourage, equip, and send out young men to preach and teach God's Word and shepherd God's people.

As we look outward, God has continued to bless and use our three church plants, Green, Lake County, and Westside, to spread the gospel. At the end of 2017, God answered several years of prayer by providing a physical facility for Parkside Church Lake County. God's faithfulness makes us even more eager to see the expansion of the gospel regionally. As we thank God for what He has done, we pray that He will continue to raise up and send out faithful pastors.

God continues to create opportunities for us to help people throughout the world to become followers of Christ. We see the Lord calling us to ministries in Japan, East Asia, North India, the Middle East, South Africa, North Africa, Europe and 10 countries throughout Latin America. In 2017, Mark and Patti Bean, our missionaries in Peru, moved us one step closer to publishing Bibles in six Quechua language dialects. We pray that this work will be completed in 2018.

God continues to help us to see the fields that are ripe for the harvest. May we be instruments in His hands used to raise up and send out workers locally, regionally, and globally. It is important for each one of us to regularly take time to reflect upon God's abundant faithfulness by reviewing the ways in which He has helped us in the past. His faithfulness gives us confidence for the present and the future. Jesus's final words to His disciples in Matthew 28:18-20 provide encouragement for us today: "All authority in heaven and on earth has been given to me. # **2017 Annual Report** | Parkside Church

#### Administration Council

Once again our members and friends have responded to our needs cheerfully and generously. "Each man should give what he has decided in his heart to give, not reluctantly or under compulsion, for God loves a cheerful giver." 2 Corinthians 9:7

We are thankful to the Lord that we can report such positive results. The following provides a general overview of our 2017 financial results and condition at year-end to be read in conjunction with the Statements of Activities and Financial Position included in this Annual Report.

#### Parkside Church

2017 revenues totaled \$8,645,325 which reflected an 11% increase in general fund contributions compared to 2016. 2017 expenditures totaled \$8,623,908 including \$7,652,684 of operating expenditures and \$971,224 of depreciation expense. Thus in 2017, Parkside's revenues exceeded expenditures by \$21,417. Parkside's Building Expansion Fund received \$114,503 in contributions, \$900,000 of transfers from the General Fund and had an \$854,655 balance at year-end. Parkside's operating budget for 2018 is \$8,000,000.

#### Parkside Church - Green

2017 revenues totaled \$679,198 which reflected an 11% increase in general fund contributions compared to 2016. 2017 expenditures totaled \$703,220 including \$622,739 of operating expenditures and \$80,481 of depreciation expense. Thus in 2017, Green's expenditures exceeded revenues by \$24,022. Green's Building Expansion Fund received \$9,493 in contributions, \$22,450 of transfers from the General Fund and had a \$61,959 balance at year-end. Green's operating budget for 2018 is \$640,000.

#### Parkside Church - Lake County

2017 revenues totaled \$522.121 which reflected a 4% increase in general fund contributions compared to 2016. 2017 expenditures totaled \$415.179 including \$404.031 of operating expenditures and \$11.148 of depreciation expense. Thus in 2017, Lake County's revenues exceeded expenditures by \$106,942. Lake County's Building Expansion Fund received \$63,696 in contributions, \$77,500 of transfers from the General Fund and had a \$791,358 balance at year-end. Lake County's operating budget for 2018 is \$475,000.

#### Parkside Church - Westside

2017 revenues totaled \$543,954 which reflected a 33% increase in general fund contributions compared to 2016. 2017 expenditures totaled \$337,660 including \$328,491 of operating expenditures and \$9,169 of depreciation expense. Thus in 2017, Westside's revenues exceeded expenditures by \$206,294. Westside's Building Expansion Fund received \$10,050 in contributions, \$60,000 of transfers from the General Fund, a \$100,000 transfer from Parkside Church and had a \$438,933 balance at year-end. Westside's operating budget for 2018 is \$375,000.

#### 2017 Audit

The firm of J.A. Doran & Associates, Certified Public Accountant, is responsible for the performance of the audit for 2017. A copy of the J.A. Doran & Associates audit report and related audited financial statements may be reviewed in the church office.
